Dear Senator Melvin and Representative Pierce:

Please consider my request in your capacities as the chair of the legislative committees that deal with military matters, to hold a public hearing on the investigation and report on the Arizona National Guard.

As you may have seen in media reports, which are attached, there are troubling accusations that some members of the Arizona National Guard have been engaging in a pattern of unacceptable behavior, including sexual abuse, firearms abuse, as well as retaliation against those who reported criminal and unethical conduct. The Governor appointed Major General Ricky Adams to investigate these allegations and Major General Ricky Adams' report is expected to be completed and provided to the Governor very soon.

The submission of the investigative report to the Governor should not be the end of this matter. Many families have members that participate in the Arizona National Guard; some young people see it as an opportunity for training and career development. The public must be allowed to review the report and provide testimony to the legislature regarding their experiences with the National Guard in this state. Only through a public hearing can we get a full airing of the allegations and the remedies set forth in the Major General Ricky Adams' report.

I look forward to hearing from you on the arrangements for a public hearing to review the investigative report and to invite members of the public to provide their testimony on the activities of the Arizona National Guard. If I can be of any assistance in arranging the public hearing, please do not hesitate to contact me.

To reinstate your Indiana drivers license, you must do the following: Visit your local BMV office; Pay a reinstatement fee; Fill out a reinstatement application; Present any necessary documents and/or proofs.. What you can do is file a Petition with the following information: (1) that the person who owes the fee for reinstatement of the driver's license: (A) is indigent; and (B) has presented proof of future financial responsibility; and (2) waiver of the fee for reinstatement of the driver's license is appropriate in light of the person's character and the nature and circumstances surrounding the person's license suspension..
